



Congratulations to Joe Hemming, Fly Fisherman Magazine 2019 Conservationist of the Year!



On January 19, 2019, a ceremony was held at the Ralph A. MacMullen Conference Center in Roscommon, Michigan to honor Joe Hemming, former board member of ARPOA and President of Anglers of the Au Sable. The award was given to Joe by Ross Purnell, Publisher and Editor of the *Fly Fisherman*. As part of the award, Anglers of the Au Sable received a donation from Simms Fishing Products in the amount of \$10,000. Rich Hohne, Senior Director of Marketing and Brand Management of Simms was also present to deliver the check. By the end of that evening Joe's name became synonymous with "River Warrior."

Fish Farm Update

Four years of legal fighting is over. The commercial fish farm that was being operated at the old Grayling fish hatchery is no more. How did this happen and what happens now?

Last fall, Anglers of the Au Sable (Anglers) settled its lawsuit against Harrietta Hills Trout Farm, LLC and its operation of a commercial fish farm at the Grayling Hatchery. In addition, at the same time, Anglers dismissed its appeal of the decision by the DEQ Director to allow this commercial fish farm to operate. That decision by the DEQ Director had followed an 18-day administrative law hearing where Anglers had presented a number of experts who testified to the harm being caused to the river. As background, the DEQ, in issuing its permit at the Grayling Hatchery, would allow this commercial fish farm to be the largest fish farm in the state by allowing production of up to 300,000 pounds of fish. The permit also allowed the discharge by the fish farm of 1,600 pounds of phosphorus as well as almost 160,000 pounds of total suspended solids (consisting of fish feces and uneaten fish food) to be discharged every year into the Au Sable River. This discharge, among other harms to the river, allowed algae growth to increase in the river, allowed dissolved oxygen to decrease and dramatically increased the risk of whirling disease. In short, this permit to pollute posed the biggest threat to the Au Sable River in recent memory.



The settlement of both of these lawsuits came about through mediation that was conducted as part of the court process. Out of this court-ordered mediation emerged a settlement that was a classic win-win. Anglers paid the fish farm \$160,000 to cease operations and agree never again to conduct aquaculture operations in the Au Sable watershed. The Crawford County Board of Commissioners agreed to assign the 20-year lease previously given to Harrietta Hills to a new entity, Grayling Hatchery, Inc., which will now operate the hatchery. Instead of being operated as a commercial fish farm, the hatchery will now be operated with the purpose of educating the public about the river and its resources.

Most importantly, the Au Sable River is the big winner in this settlement, as the additional pollution has now ceased.

Going forward, the Grayling Hatchery, operated by the Grayling Hatchery, Inc., will be open to the public between Memorial and Labor Day. Brook, brown and rainbow trout will reside in the raceways helping to educate the public about the Au Sable River. It's hoped eventually that arctic grayling fish, for which the City of Grayling was named, will again swim in the raceways. A pond located on the hatchery property is a perfect venue to introduce the public, especially youth, to the sport of fly fishing. As such, the pond will be used for fly fishing lessons. Partnerships are being sought with various educate the public about the Au Sable River.



Anglers of the Au Sable also has a goal in all of this. Ultimately, and hopefully not too long into the future, the East Branch above and below the Grayling Hatchery will be reconnected to allow free and unimpeded movement of trout.

The Anglers of the Au Sable, in sticking to its mission of preserving and protecting the Au Sable River, has helped start a new chapter in the life of our beloved Au Sable River.

Controversial Ban on Alcohol Now on Hold

A controversial ban on alcohol use on three Michigan rivers has now been put on hold until at least 2020. The new policy would affect the National Wild and Scenic River sections of the Au Sable, Manistee, and Pine rivers. The closure order was intended "to address persistent public safety issues and protect natural resources on rivers of outstanding recreational value," said Huron-Manistee National Forests Supervisor Leslie Auriemmo." Our goal is to create a safer, more sustainable, and more enjoyable experience for the thousands of visitors who recreate on our National Wild and Scenic Rivers each year." Specifically, it would apply on and within 200 feet of the:

- Au Sable River between Mio Dam Pond and 4001 Canoe Landing
- Manistee River between Tippy Dam and the Huron-Manistee National Forests' administrative boundary
- Pine River between Elm Flats and Low Bridge.

Private lands, developed campgrounds and designated campsites within those river corridors would not be affected. Violation of the order would be punishable by a maximum fine of \$5,000 and imprisonment for up to five years.

Though some people welcomed the ban, some business owners and community leaders said they were caught off guard and worried about the impact of the policy on tourism. Officials are convening a group of business owners, government leaders and residents to come up with a plan that addresses the the public safety and environmental issues associated with alcohol use on the waterways.
